Note: Oasis Pet Hotel Inc. reserves the right to restrict a pet's access to play with other dogs due to temperament, behaviours and/or access to appropriate playmates. If play with others is deemed unsafe or inappropriate, your dog will still receive an individual exercise period.

Special Instructions

All Dogs must be at least 12 weeks of age or older.

All dogs must be spayed or neutered.

All dogs must have up-to-date vaccinations. Owners must submit written proof of DHLPP and Bordetella vaccinations. Rabies is required for puppies over 4 months of age.

All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable disease in the last 30 days. Upon admission, all dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted. All dogs admitted must have proof they are on flea medication such as Sentinel, Advantage, or Revolution.

All dogs admitted to interactive daycare (where they may play with other dogs) must be non-aggressive and not treat or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behaviour towards any person or any other dog(s).

Terms/Conditions:

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked out of Oasis Pet Hotel Inc.
2. Owner further agrees to pay all costs and charges for special services requested and all veterinary costs (if necessary) for the pet during the period said pet is in the care of Oasis Pet Hotel Inc.
3. Owner further agrees the pet shall not leave the facility until all charges due are paid by Owner.
4. By signing this agreement and leaving Owner's pet with Oasis Pet Hotel Inc, Owner certifies to the accuracy of all information provided. Oasis Pet Hotel Inc. reserves the right to deny admittance to owner's pet for any reason at any time.
5. Oasis Pet Hotel Inc. shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. The dog(s) is to be fed properly and regularly, and to be housed in clean, safe quarters. The dog (s) is to be exercised appropriately to its age and/or health, and this agreement.
6. If interactive daycare is provided Owner recognizes and accepts potential risks involved in such activity. The Owner agrees to be solely responsible for any harm caused by the dog(s) while the dog(s) is/are boarding at Oasis Pet Hotel Inc. to any other pet and/or to facility equipment.
7. Oasis Pet Hotel Inc, its staff and/or volunteers are not liable or responsible for any problems that might develop, provided reasonable care and precautions are followed, and Owner hereby releases them of any liability of any kind whatsoever arising from the pet's attendance and participation at Oasis Pet Hotel Inc.
8. Owner further understands and agrees that dogs can sometimes receive minor cuts and/or scratches during boarding or daycare, and any problems that develop with Owner's dog(s) will be treated as deemed best by staff and volunteers of Oasis Pet Hotel Inc. at their sole discretion. Furthermore, Owner assumes full financial responsibility for any and all expenses involved, including the necessity of veterinary emergency care.
9. Owner certifies he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
10. Owner certifies the pet(s) is/are in good health and has/have not been ill with any communicable condition in the last 30 days. I further certify that my pet(s) have not harmed or shown aggressive or threatening behaviour towards any person or any other dog.
11. Oasis Pet Hotel Inc. shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from pet(s) boarding or daycare at Oasis Pet Hotel Inc.
12. Owner agrees not to enter the kennel without an Oasis Pet Hotel Inc. staff member.
